

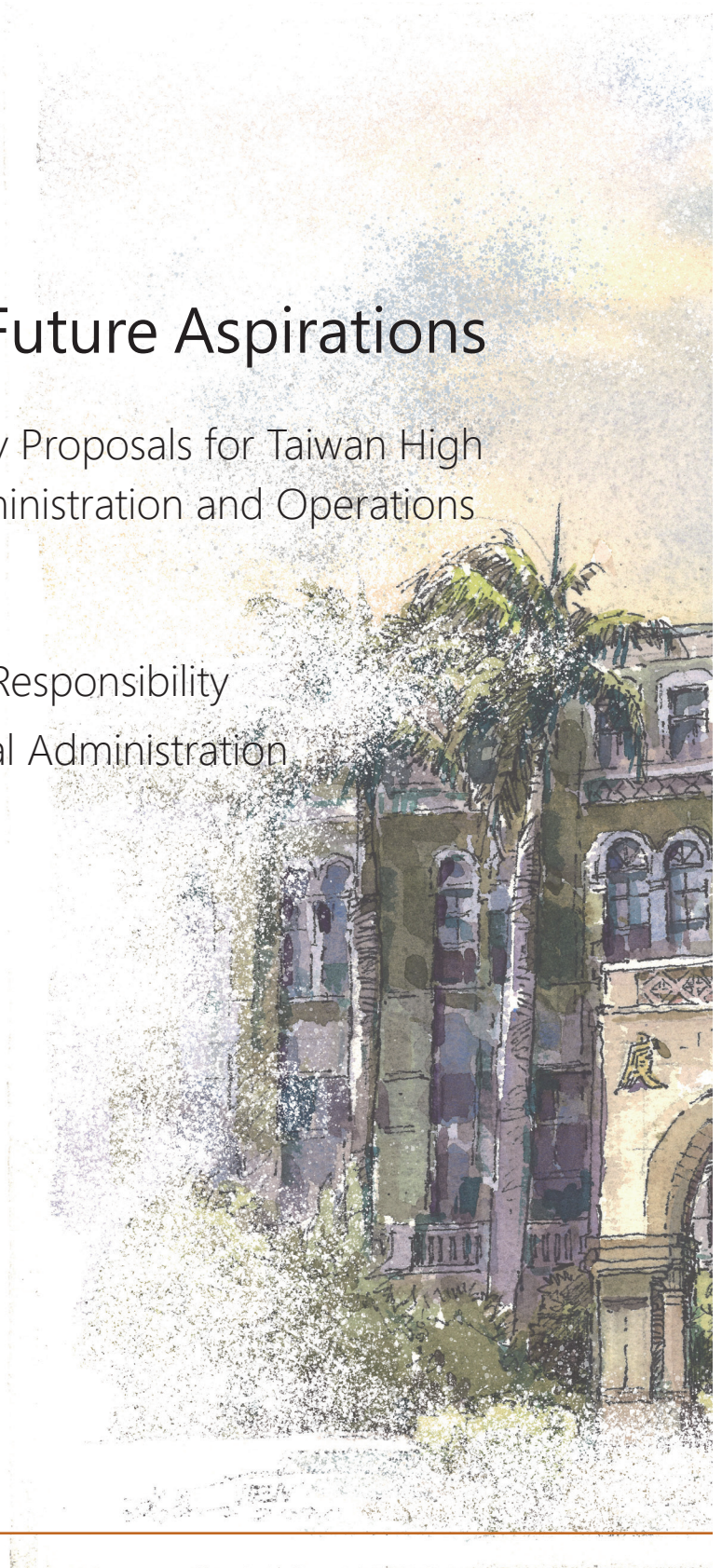

The Taiwan High Prosecutors Office (THPO) is planning for medium-term reforms of prosecution administration and responsibilities in a "forward-looking", "strategic", and "effective" direction, to both promote the benefits and to prevent any disadvantages. We plan to task the Section Chiefs or supervising prosecutors for prosecutorial administration in the Personnel Office, Accounting Office, Statistics Office, Civil Service Ethics Office, Information Management Office, Records Section, Documentation Section, Research and Evaluation Section, Data Section, Litigation Counseling Section, General Affairs Section and Bailiff Office to present their suggestions on the status quo, difficulties, innovations or prospects affecting their responsibilities. We will also invite Deputy Chief Prosecutor Chen, Wei-Lien to share his thoughts on his tenure as THPO Deputy Chief Prosecutor, and Chief Secretary Wu, I-Ming to share his thoughts on his tenure as of the THPO Chief Secretary, so that their valuable experience can be passed forward. Also, we will ask the relevant prosecutors to analyze possible developments and difficulties in handling the following special or new types of crimes and prosecutorial operations, and to discuss related improvements or future prospects: For example, how we need to strengthen functioning of the Investigation Supervision Unit for Financial Crimes, Money Laundering Prevention, Trade Secrets Criminal



Cases, Corruption cases, Combating Crimes against Developing the Green Energy Industry, Environmental Crime, Investigating Guns, Ammunition and Knives Act Violations, Preventing Racketeering Organization Crime, National Security cases, Drug Interdiction and Enforcement, Drug Dependency/Addiction Treatment, Crimes Against People's Livelihoods, Prosecutorial Agency responsive measures during the epidemic, Penalty Enforcement, Loot Storage Management, Science and Technology Investigation, Applications of Electronic Monitoring equipment, Combating Trans-Border Telecommunication Fraud racketeering organizations, Cybercrime, RFID Intelligent Stolen Evidence Warehouse, Citizen Judges System, The New Confiscation System and Prospects for Future Statutory Revisions, Interdisciplinary Cooperation in Investigation and Criminal Prosecutorial Investigations in Major Transportation Occurrences, Conducting Confirmed Criminal Case Guilty Verdict Review Committee Operations, Founding and Prospects of the Intellectual Property Branch of the Taiwan High Prosecutors Office, Our humble opinions on the present stage of the development blueprint for the Taiwan High Prosecutors' Office, and International and Cross-Straits Criminal Justice Cooperation. We hope to assist this Office in supervising prosecutorial administration and operations from a "macro" and "micro" perspective and by integrating unifying related resources.
